

Funding History of the Interstate Corridors

- □ In 1956, President Eisenhower signed the Federal-Aid Highway Act. (Authorized \$25B to build 41,000 miles of Interstate Highways over twelve years)
- October 14, 1992: The original Interstate Highway System is proclaimed to be complete with the opening of I-70 through Glenwood Canyon in Colorado.
- When completed, the IH system ended up costing \$114 billion (equivalent to \$618 billion in 2023) and took 35 years.




Funding History of National High Priority Corridors

- ☐ Intermodal Surface Transportation Efficiency Act of 1991 (ISTEA)
 - □ Corridors were designated in Federal transportation legislation as high priority corridors on the National Highway System. The ISTEA originally designated 21 corridors. Authorized funding for FY 92-97 for some HPC segments
- □ Transportation Equity Act for the 21st Century (TEA-21) (1998)
 - □ authorized funding for fiscal years 1998 through 2003 for some specific high priority corridor segments.
 - Also, **some formula funds** from several programs were used to fund improvements to HPC's.
 - □ In addition, beginning in FY 1999, the planning and development of high priority corridors was eligible for funding under the **discretionary National Corridor Planning and Development Program.**

Funding History of National High Priority Corridors

- □ Safe, Accountable, Flexible, Efficient, Transportation Equity Act: A Legacy for Users (SAFETEA-LU) (2005)
 - □ Various sections for SAFETEA-LU provided funds for these high priority corridors.
 - ☐ Formula funds for the NHS, STP, Bridge Program, the Coordinated Border Infrastructure Program and in certain instances, Interstate Maintenance may be used to fund improvements to high priority corridors.
- ☐ Moving Ahead for Progress in the 21st Century Act (MAP-21) (2015)
 - ☐ There were **no funding allocations** to specific projects.
 - ☐ The authorization of "such sums as may be necessary" in SAFETEA-LU continues, but funds will be available only if appropriated by Congress.
 - MAP-21 identified national goal areas (e.g. safety, system reliability, infrastructure condition, congestion reduction)

- □ Nationally Significant Freight and Highway Projects (INFRA) **\$7.25B**
- ☐ State Incentives Pilot Program (Set-aside within Nationally Significant Freight and Highway Projects INFRA) \$750M
- □ National Highway Freight Program **\$7.15B**
- □ Rural Surface Transportation Grant Program \$2B

High Priority Corridor Funding in the Infrastructure Investment and Jobs Act (IIJA)(2021)

- □ National Highway Performance Program \$148B
- □ Surface Transportation Block Grant Programs **\$72B**
- □ Local and Regional Project Assistance Grants (RAISE) **\$7.5B**
- □ National Infrastructure Project Assistance (Megaprojects) **\$5.0B**

Funding the Ports-to-Plains Corridor?

- Maximize IIJA Funding
- ☐ Texas has funded \$20 billion for Corridors in their Ten-Year Unified Transportation Program (UTP)
- ■New Mexico has funded a "New Mexico Match Fund" to leverage State funding towards Federal funds
- □ Explore Non-traditional funding sources (DOD, Homeland Security, Private)



- Explore Non-Traditional Funding Sources (Dept of Commerce, Private)




