

America Needs A Multi-State Future Interstate Highway Formula Funding Program

Program Ended in 1992

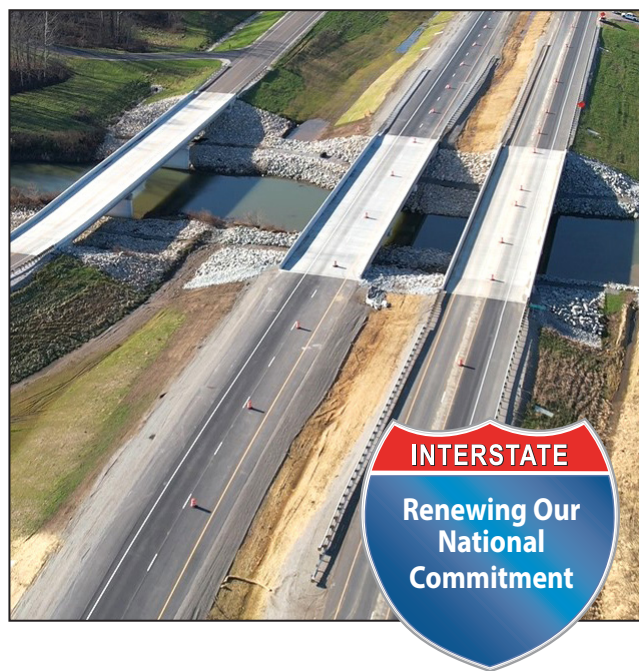
- ❑ There is currently NO dedicated federal funding to plan and construct Future Interstate Highways.
- ❑ Work on the Interstate System began in the 1950s with 90% guaranteed federal funding.
- ❑ The original system was largely complete by 1985 and officially ended in 1992.
- ❑ Starting in 1991 the High Priority Corridors concept recognized the need to expand the system but for three decades no dedicated federal funding has been forthcoming. Not a single congressionally authorized multi-state Future Interstate has been completed.
- ❑ A renewed federal commitment to expanding the Interstate System is needed.

Time For A Solution

- ❑ Congress should make a Multi-State Future Interstate Highways Formula Funding program part of the next federal surface transportation reauthorization bill with dedicated funding.
- ❑ Funding would be distributed to State DOTs based on the number of unconstructed miles of multi-state authorized Future Interstate in each state.
- ❑ States would be required to use the formula funding to plan and construct multi-state interstates.
- ❑ Guaranteed federal funds for the program would be in addition to each state's Highway Trust Fund rate of return calculation.
- ❑ States would have the flexibility to determine annual priorities for corridor development.

Impacts of IH System Are Dramatic

- ❑ The Interstate Highway System has enabled a cumulative \$3 to \$5 Trillion in added national GDP since 1970.
- ❑ Freight costs per ton-mile have dropped 55% due to gains in efficiency.
- ❑ Rural counties with interstate access report 19% higher per capita income than those counties without.
- ❑ Future interstate corridors will replicate this strong return on investment.



A dedicated funding mechanism is essential to completing vital interstate corridors. Congress should act with the same boldness that built the Interstate System 70 years ago.

The nation needs a renewed federal commitment to expanding and modernizing the Interstate Highway System to meet 21st-Century transportation, economic and security challenges.

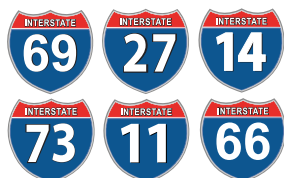


22 States Include a Segment of a Current Congressionally Authorized Multi-State Future Interstate Highway

- ☐ Renewed investment in interstate highways will support the US manufacturing renaissance
- ☐ These 22 states include 56% of the nation's population and 60% of all manufacturing jobs
- ☐ 72% of all freight tonnage travels by truck on the nation's roadways
- ☐ High design standards mean that Interstate System highways are the nation's safest
- ☐ Highway construction creates jobs during planning, development and construction and leads to new permanent job growth in local communities

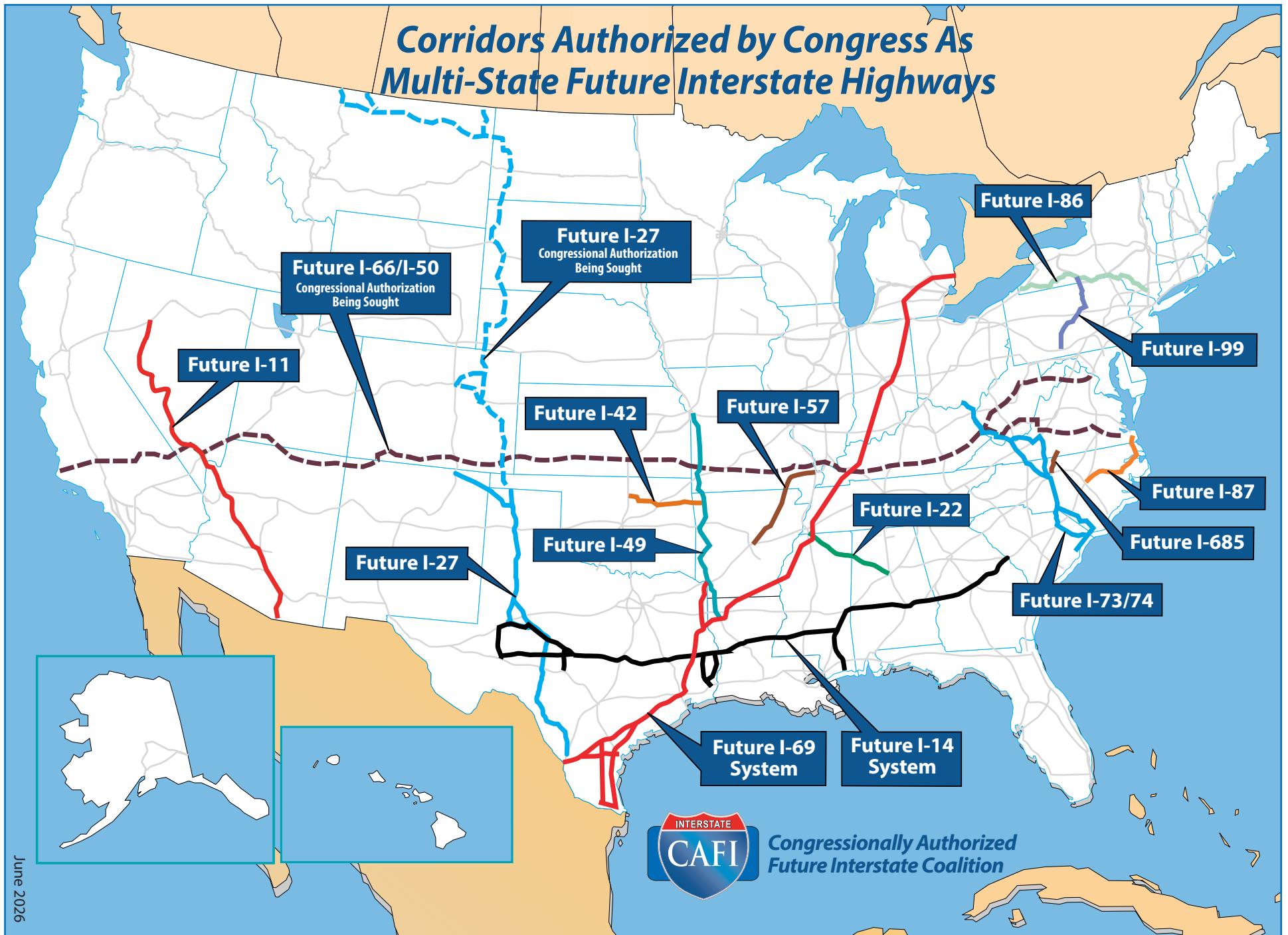
